

## MALAYSIA TWIN DEAL X Terms & Conditions:

### Deal 1 – Value Added Support for Participants:

- Malaysia Twin Deal X campaign is opened to international organisations only.
- Valid for groups of 50 pax and above with a minimum 3-night stay at a 4- or 5-star hotel/resort.
- All confirmed bookings must be made by 31 December 2015
- Applicable to international corporate meetings and incentive group as defined by SITE.  
*Incentive groups are defined by SITE (Society of Incentive Travel Executives) as a global management tool that uses an exceptional travel experience to motivate and/or recognise participants for increased levels of performance in support of organisational goals.*
- The event must be held in Malaysia before 30 June 2016 at the latest.
- The Twin Deal support is not valid in conjunction with other MyCEB Event Support Programme or promotional offers.
- The Twin Deal support is not valid for corporate meetings and incentive groups that are attending the conference or exhibition organized during the same period.
- The support level is based on the actual number of confirmed delegates. For partial cash support, the organization and/or Incentive Planner must make payment directly to the local supplier.
